## OVERVIEW

Robin (she/her) is a global health and human rights leader and advocate, cross-disciplinary organiser and mobiliser of people and ideas. She has led significant cultural and organisational developments across sectors. Robin's broad understanding of AIDS, community responses, gender equality, global health and COVID underpins her activism, in particular with communities, as an implementer, adviser and donor in a broad range of places, having lived and worked in Africa and Asia as well as donor countries. Robin brings extensive experience leading organisations, facilitating work within the community-based sector, developing strategies and advancing policies through civil society, the UN and international systems, and with governments. Renowned for exceptional strategic planning and communication skills, and a big picture, visionary approach, Robin has leveraged her extensive expertise and networks to advance policies, build partnerships and found new movements and groups, notably the global SheDecides and Women4GlobalFund movements. Building on close to 40 years' work in AIDS, global health and gender equality, Robin was the first Head of Diversity and Inclusion at Brighton College. She served as Executive Director of Frontline AIDS after stepping down as Vice Chair of the Technical Review Panel (TRP) of the Global Fund to fight AIDS, TB and Malaria. Robin is widely published and currently working on a new book about the early days of the two pandemics of AIDS and COVID.

These independent experts meet in periodic windows to review and assess funding requests for allocations (over US\$13 billion for Grant Cycle 7 (GC7), the 2023-2025 allocation period) to ensure that Global Fund investments are technically sound, strategically focused and poised for impact and sustainability. The TRP provides an advisory role to the Global Fund Board, principally through reflections on lessons learned from the funding requests. I chaired the TRP Working Group (WG) that delivered the Observations Report (for GC6), the FCDO WG

reporting to the UK government on efforts to increase prevention in GC6; the WG of TRP experts that advised on refining Application Materials for GC7, and prepared the *revised TRP Review Criteria* to align with the new Global Fund Strategy. I champion gender equality, diversity and inclusion across the TRP's work and practices, and also served as TRP representative to the Technical Evaluation Reference Group to ensure cross-fertilisation and continuous improvement.
